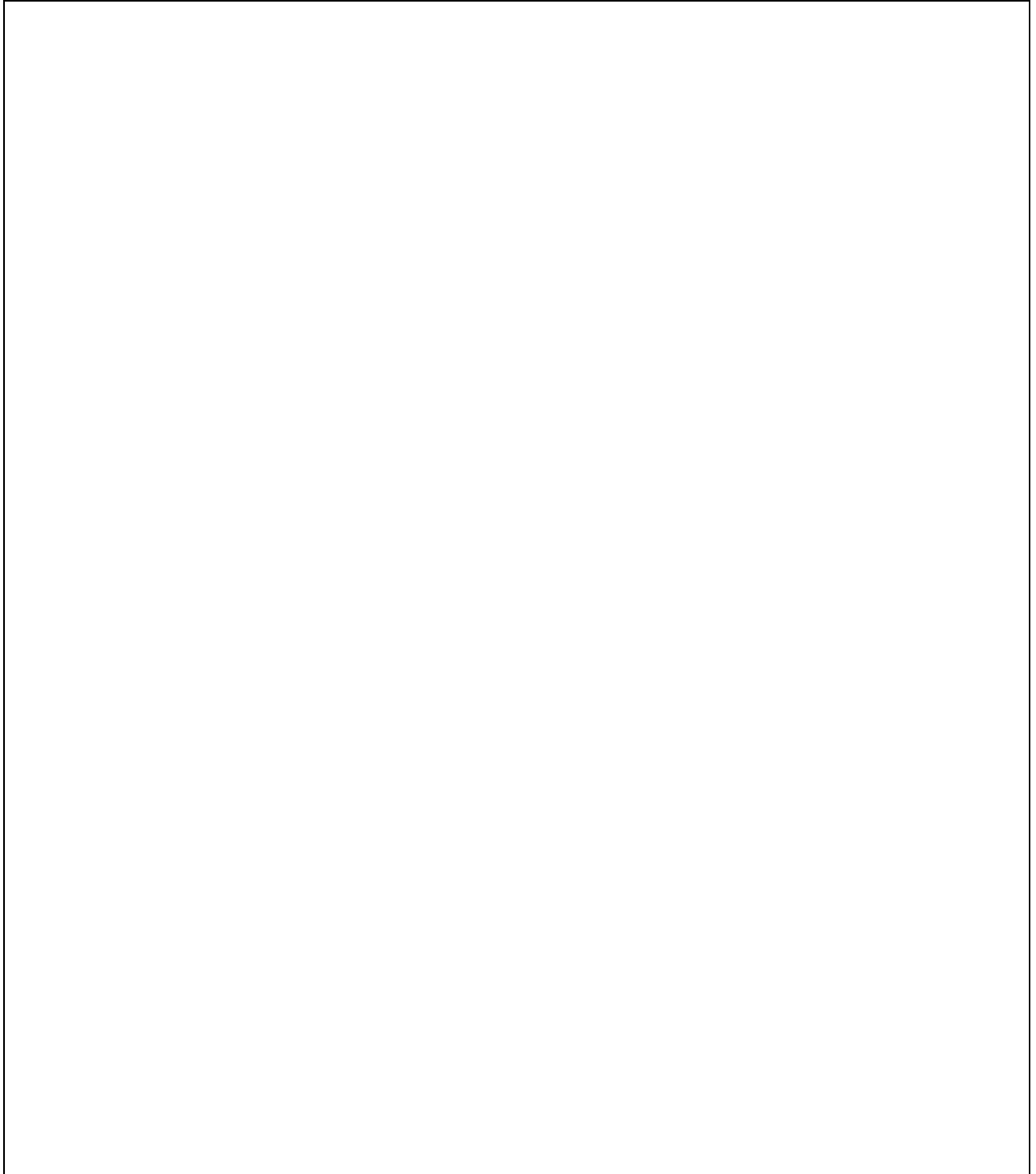

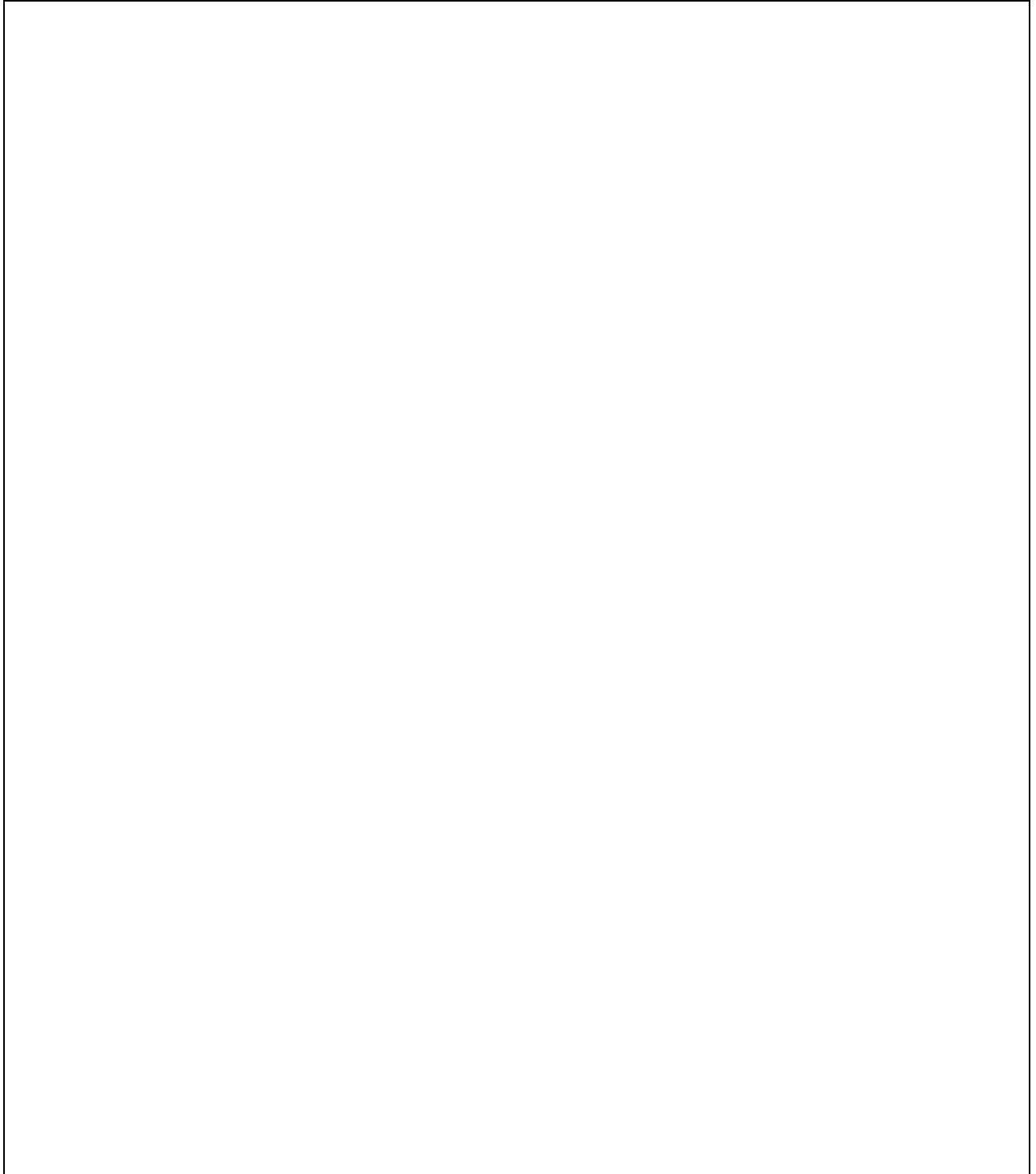
Item 1 Cover Page

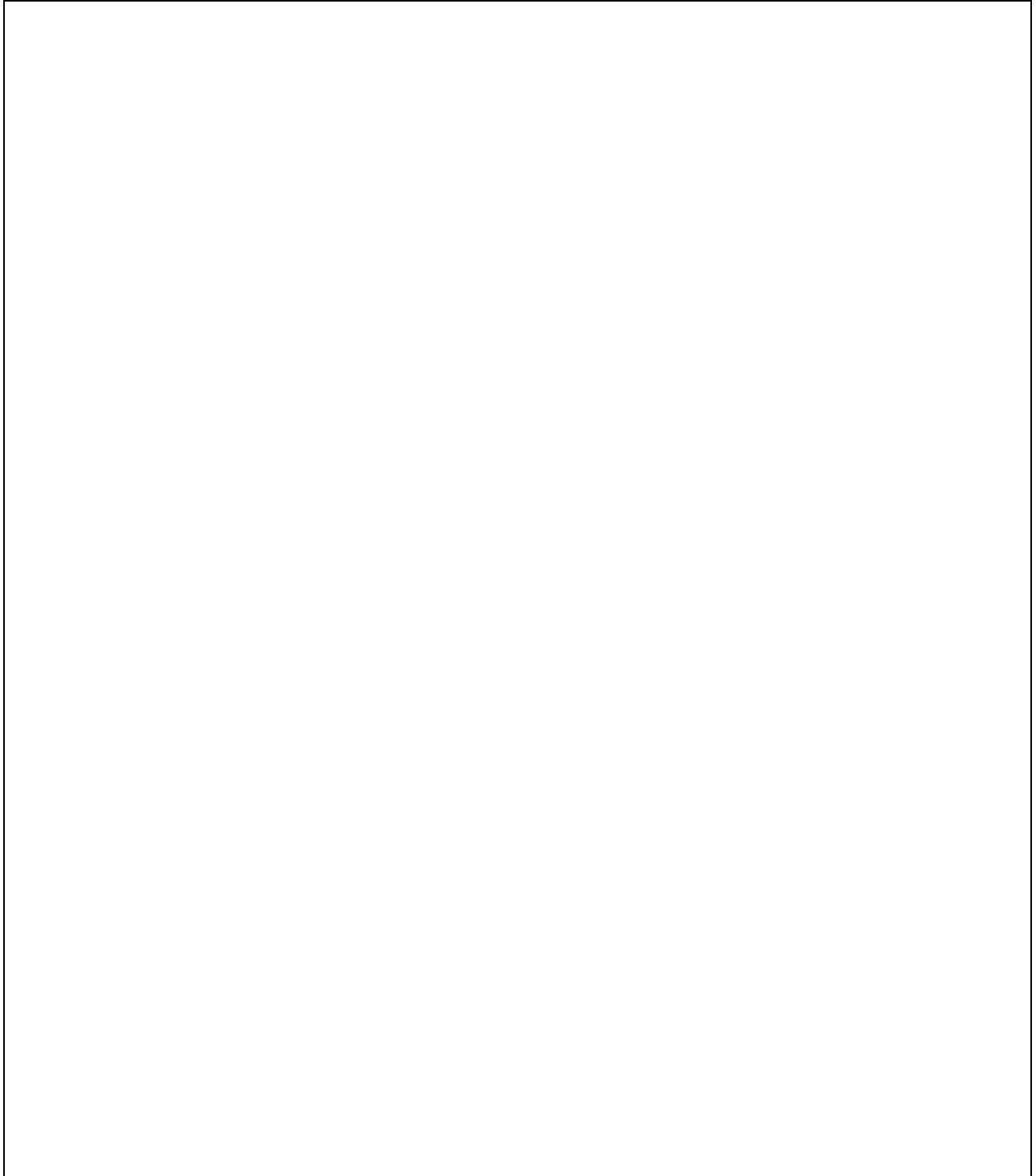



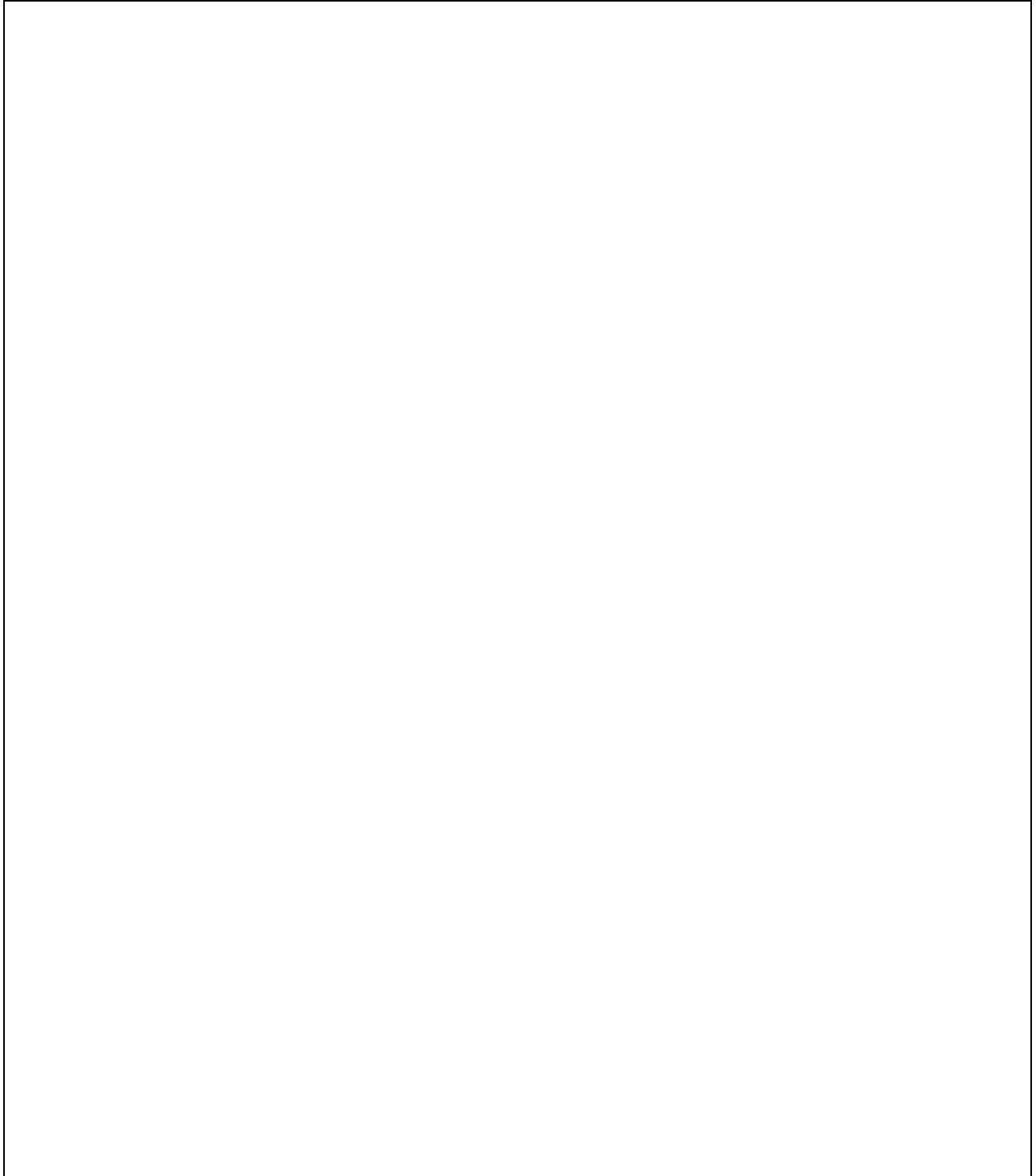
